Public Authorities, Contractors and Sole Traders are now able to purchase, apply and resell our world-leading ready-mixed pothole repair product

The Quikfix “Approved User” license enables public bodies, commercial contractors and sole traders to use our Quik-a-fix Instant Road Repair product in designated areas. Here’s how it works.

Who can apply to be an Approved User ?

Approved Users may be road authorities or agencies, municipal councils, public bodies and NGO’s, companies, contractors and individual traders. In fact, anyone anywhere with the resources and ability to purchase and use Quik-a-fix Instant Road Repair. A license also enables the Approved User to resell the product to third-party customers.

What does it cost ?

There are no upfront fees to be paid although we do expect a minimum quantity of product to be purchased each and every year. This quantity is negotiable based on the amount of product likely to be needed and can be increased if demand warrants further supplies at any time.

Where can I use Quik-a-fix and for how long ?

The Approved User license defines the area in which the user is able to operate with the product. The area may be a particular community, city, region or state. Licences are usually territorially non-exclusive but, in some instances, may provide the user with absolute exclusivity of use in a specified area.

The duration of the license is set out and may be up to 20 years but can be for a shorter period with regular renewals agreed mutually.

What will I need ?

In addition to the means to pay for the product (plus shipping) we will need to be satisfied that you have the right equipment, tools, vehicles, storage and manpower to be able to use it properly. We will advise on appropriate equipment and can supply if necessary.

Will I get help ?

Of course we will provide initial training and ongoing support for you and your personnel.

We will also assist with technical information and marketing materials if required. You will be able to state on your letterheads, vehicles and publicity that you are an “Approved User of Quikfix Instant Road Repair”.

Can I sell other Quikfix products and services ?

When the opportunity arises to sell other Quikfix products and services to your customers we will issue an additional license or agree specific terms and conditions.

An Approved User does not have rights to manufacture any of our products unless specifically licensed to do so.
